Demonstration Application

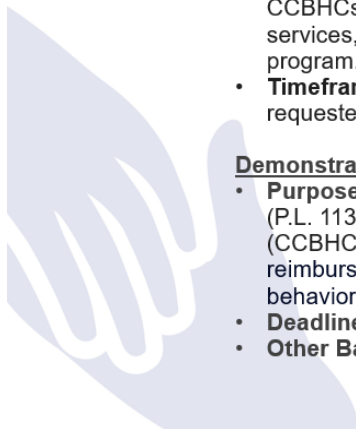


CCBHC Planning Grant

- **Purpose:** The CCBHC planning phase assists states in certifying clinics as CCBHCs, establish prospective payment systems for Medicaid reimbursable services, and prepare an application to participate in a four-year demonstration program.
- **Timeframe:** April 1, 2023 thru March 31, 2024, one-year no-cost extension requested, approved.

Demonstration Application

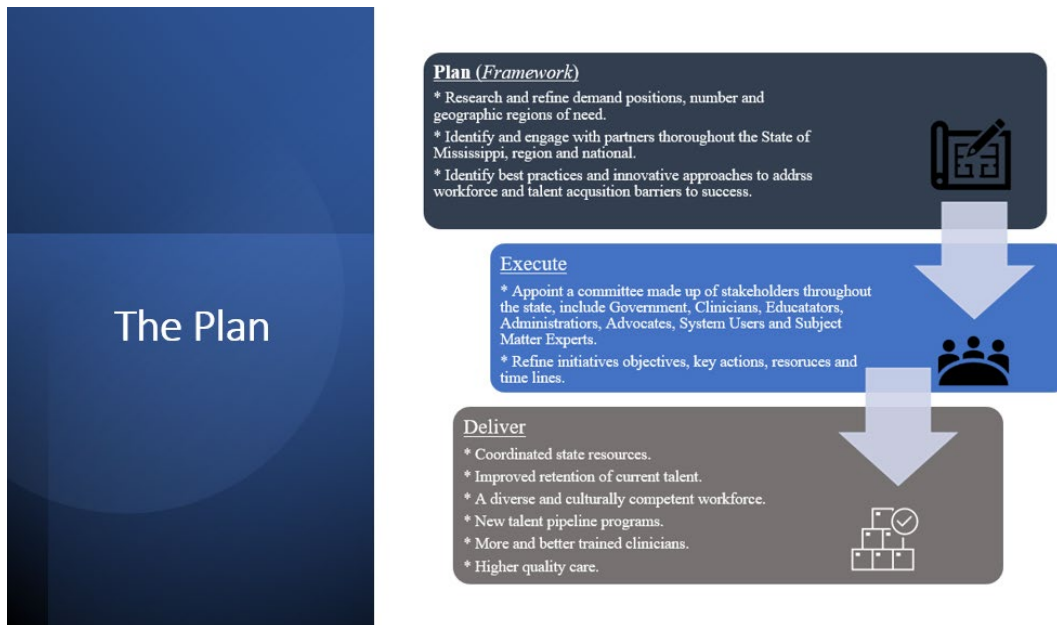
- **Purpose:** Section 223 of the Protecting Access to Medicare Act (PAMA) of 2014 (P.L. 113-93)1 authorized the Certified Community Behavioral Health Clinic (CCBHC) demonstration to allow states to test a new strategy for delivering and reimbursing a comprehensive array of services provided in community behavioral health clinics.
- **Deadline:** Submitted on March 20th, 2024, *Notification by June 17th*
- **Other Background:** 25 states were eligible to apply, 13 states applied



Amy addressed the Mississippi CCBHC Strategic Action and Resource Roadmap.



Mark Scott shared a workforce development update to include the framework the committee is using and the development of a strategy for the licensed professionals staffing initiative. In addition, he shared the pipeline program that is in development with the Mississippi Community College Board.



Nikki Tapp provided an update on state and local efforts to prioritize eligibility for CCBHC Certification and reviewed state and national efforts to include acceptance to the CCBHC Supported Employment Policy Academy, the intention to apply for the CCBHC Crisis Continuum Learning Community and the National Academy for State Health Policy on workforce.



State and National Efforts



- **CCBHC Supportive Employment Policy Academy**

- This Policy Academy focuses on evidence-based Supported Employment in Certified Community Behavioral Health Clinics (SE-CCBHC). The goal of state teams is to adopt evidence-based Supported Employment and implement them in CCBHCs across their state.
- Mississippi will join 4 other states in this process to improve Supported Employment services and outcomes in CCBHC's.
- Even though Supported Employment is provided in all CMHCs in Mississippi, these programs report struggling with:
 - identifying workforce to provide Supported Employment, and other behavioral health services;
 - training and consultation for existing Supported Employment workforce; and
 - building community partners with private sector employers, and other employers to ensure adequate placement opportunities for program participants.

- **Applying for: CCBHC-Crisis Continuum Learning Community**

- The purpose of this learning collaborative is to support states in building crisis response systems that maximize the role of CCBHCs in those systems.

- **Applying for: NASHP**

- **Access CCBHC State Technical Assistance Center**
