### **CCBHC's Value for Mississippi**



- Improve access to and delivery of community-based behavioral health services.
- Address gaps or barriers to care in Mississippi
- Establish sustainable funding for additional investment in quality, evidence-based mental health and substance use services.
- Offer more competitive wages because of the cost-based reimbursement that can aid in alleviating workforce shortages.
- Be accountable for quality outcomes.
- Engage stakeholders and consumers of mental health services, including youth, family members, and community leaders, to provide input on a customizable approach to care that increases responsiveness to the needs of Mississippians.

# **Demonstration Application**



#### **CCBHC Planning Grant**

- Purpose: The CCBHC planning phase assists states in certifying clinics as CCBHCs, establish prospective payment systems for Medicaid reimbursable services, and prepare an application to participate in a four-year demonstration program.
- Timeframe: April 1, 2023 thru March 31, 2024, one-year no-cost extension requested, approved.

#### **Demonstration Application**

- Purpose: Section 223 of the Protecting Access to Medicare Act (PAMA) of 2014 (P.L. 113-93)1 authorized the Certified Community Behavioral Health Clinic (CCBHC) demonstration to allow states to test a new strategy for delivering and reimbursing a comprehensive array of services provided in community behavioral health clinics.
- **Deadline:** Submitted on March 20th, 2024, *Notification by June 17th*
- Other Background: 25 states were eligible to apply, 13 states applied

#### **Part 2: Program Narrative Overview**

The Program Narrative describes the State's readiness to participate in the demonstration program and project the impact of participation.

- Scored up to a total of 80 points and may not exceed 30 pages.
- Each of the sections will be scored as listed below:
  - A. Solicitation of input by stakeholders in developing CCBHCs: 10 points approximately 3 pages
  - B. State capacity to support CCBHC and certification of clinics as CCBHC: 30 points approximately 11 pages
  - C. Development of enhanced data collection and reporting capacity: 10 points approximately 4 pages
  - D. Participation in the national evaluation: 15 points approximately 6 pages
  - E. Projection of the impact of the State's participation in the Demonstration program: 15 points approximately 6 pages

# Part 3, Section 2: CCHBC PPS Rate-Setting Methodology Options

- Start by selecting PPS-1, PPS-2, PPS-3, or PPS-4.
- In the corresponding PPS section, explain your Demonstration Year One (DY1) Rate Data.
- Annual Rate Updates:
  - The Medicare Economic Index (MEI).
  - Rebasing CC PPS-1 rate.
- Describe your Interim Payment Methodology for Rebasing in the corresponding section.

#### **Evaluation requirements**

- The Protecting Access to Medicare Act of 2014 requires HHS to develop annual reports to Congress that address 3 topics:
  - Access to community-based mental health services under Medicaid
  - The quality and scope of services provided by CCBHCs
  - The impact of the demonstration on the federal and state costs of a full range of mental health services




# CCBHC Strategic Action and Resource Roadmap

- \* Higher quality care.





#### **State and Local Efforts**



#### DMH has prioritized eligibility for CCBHC certification to Mississippi's eleven (11) CMHCs

- Seven (7) of the State's eleven (11) CMHC regions already have CCBHC expansion or IA grants.
- To solicit additional interest for CCBHC Certification, DMH distributed and collected provider interest forms to all CMHCs in February 2024.
  - In addition to the two (2) pilot regions that are provisionally certified, we received eight (8) interest forms from the remaining nine (9) eligible CMHCs.
- We are reviewing these interest forms, updating our training and capacity building plans, and will identify timing to solicit additional CCBHC certification requests. Before certifying additional CCBHCs we want to have the appropriate training and technical assistance to ensure provider capacity.

#### **State and National Efforts**



- CCBHC Supportive Employment Policy Academy
  - This Policy Academy focuses on evidence-based Supported Employment in Certified Community Behavioral Health Clinics (SE-CCBHC). The goal of state teams is to adopt evidence-based Supported Employment and implement them in CCBHCs across their state.
  - Mississippi will join 4 other states in this process to improve Supported Employment services and outcomes in CCBHC's.
  - Even though Supported Employment is provided in all CMHCs in Mississippi, these programs report struggling with:
    - identifying workforce to provide Supported Employment, and other behavioral health services;
    - training and consultation for existing Supported Employment workforce; and
    - building community partners with private sector employers, and other employers to ensure adequate placement opportunities for program participants.
- Applying for: CCBHC-Crisis Continuum Learning Community
  - The purpose of this learning collaborative is to support states in building crisis response systems that maximize the role of CCBHCs in those systems.
- Applying for: NASHP
