### <u>Purpose</u>

The purpose of this bulletin is to inform all DMH Certified Providers of the availability of the proposed revisions to the following document on the Mississippi Secretary of State's website for public comment:

2020 Mississippi Department of Mental Health (DMH) Operational Standards for Mental Health, Intellectual/Developmental Disabilities, and Substance Use Community Service Providers

## **Subject**

On June 21, 2024, DMH filed proposed revisions to the 2020 *DMH Operational Standards* with the Secretary of State's Office, designated as System Number 27554. The public comment period for this filing ended on July 16, 2024. DMH has reviewed the submitted feedback from the first public comment period and made additional revisions. The proposed revisions to the 2020 *DMH Operational Standards* are now available on the Mississippi Secretary of State's website for a second public comment period. For the ease of identifying revisions, a mark-up copy and clean copy of the *DMH Operational Standards* are included in one document available for your review. Please note that this document only incorporates changes that were made after the first public comment period. The revisions outlined in System Number 27554 are in this version but are not underlined. Follow the instructions below to access the proposed revisions:
