Introduction & Purpose

In September 2021, the Honorable Judge Carlton Reeves issued a Final Judgment and Remedial Order in the case of *United States of America v. State of Mississippi* (Cause No. 3:16-CV-622-CWR-FKB). This order included a requirement for the Mississippi Department of Mental Health (DMH) to produce an annual report on Adult Mental Health Services data. In 2023, the 5th U.S. Circuit Court of Appeals issued a ruling that reversed the lower court's finding and determined that the federal government had not adequately demonstrated that Mississippi's mental health system violated the Americans with Disabilities Act. Despite this ruling, the Department of Mental Health continues to produce statewide data related to Adult Mental Health Services. The ongoing reporting reflects DMH's commitment to transparency and accountability in the provision of mental health services, ensuring that stakeholders have access to vital information on the state's mental health initiatives.

Data Review - Background & Methodology

In response to the Remedial Order issued in September 2021, the Mississippi Department of Mental Health (DMH) hired a Chief Clinical Officer for the DMH Bureau of Behavioral Health Services and established a DMH Office of Utilization Review.

Beginning in Fiscal Year 2022, data validation and reconciliation efforts were initiated by the Chief Clinical Officer with Mississippi's regional Community Mental Health Centers (CMHCs). These efforts included conducting meetings with each of the CMHCs and specifically requiring the participation of the CMHC Executive Director (and/or a CMHC representative) as well as programmatic and data analytic staff. At the onset of Fiscal Year 2022, CMHC Executive Directors were informed of the new review and monitoring process with the expressed purpose of confirming the accuracy and reliability of the submitted monthly data through a data validation and reconciliation process. This process also served as a feedback mechanism to assist the CMHC community providers in improving their data tracking and reporting mechanisms and processes. Data validation and reconciliation processes focus on missing or incorrect values, duplicated records, corrupted values through provider Electronic Health Records (EHRs), as well as the clinical significance and meaningfulness of data reporting and successful data outcomes. Data Validation and Reconciliation Call Summaries, summarizing the content of the meetings, the data discussed, noted discrepancies, and plans to address or reconcile errors or concerns, were introduced in January 2022. The CMHC Executive Director and/or identified representative sign and date each call summary. Data Validation calls continued into Fiscal Year 2023 and 2024, being held quarterly for assessment and reconciliation purposes.

Data Validation and Reconciliation efforts were documented for each Community Mental Health Center (CMHC) in respective data spreadsheet workbooks. Data Validation and Reconciliation efforts throughout Fiscal Year 2023 and 2024 focused on comparisons and discrepancies between data submissions from the CMHCs' respective Electronic Health Records (EHRs) and the Mississippi Department of Mental Health's Data Warehouse. These workbooks were updated prior to each Data Validation and Reconciliation call. The workbooks included review and monitoring of the following data points: Crisis Stabilization Unit Admissions, Crisis Residential Services (individuals served and units of service), Programs of Assertive Community Treatment (PACT) (individuals served and units of service), Intensive Community Outreach and Recovery Teams (ICORT) (individuals served and units of service), Intensive Community Support Services (ICSS) (individuals served and units of service), Community Support Services (individuals served and units of service), Peer Support Services (individuals served and units of service), and Community Living (individuals served and units of service). Review of Peer Bridger (individuals served and units of service) was added to the list of reviewed services in the second quarter of Fiscal Year 2024.

Although documented, units of service were not a primary focus of review during Fiscal Year 2023. Units of service vary depending on the nature of each CMHC's reporting methods in the provider's EHR (varying from billable units to unit equivalents of minutes or hours of service). Rather, the development of consistent and reliable data related to unduplicated individuals served was the primary focus during Fiscal Year 2022 and Fiscal Year 2023 data validation meetings. Given that significant progress was made in reconciling the number of unduplicated individuals served between the EHRs and the Data Warehouse, the decision was made to begin review of the units of service in Fiscal Year 2024. The first step in exploring variances amongst units was to ensure that minutes and hours of service delivery were in the correct form for the billing of the Core Services. While much progress has been made towards ensuring accuracy of time as it pertains to units, these validation efforts are expected to continue into Fiscal Year 2025.

In Fiscal Year 2022, a Mobile Crisis Data Module was developed in the DMH Web Infrastructure for Treatment Services (WITS) system for the CMHCs to use to submit their Mobile Crisis call response data to DMH. During the initiation phase, DMH held training sessions to teach CMHC Mobile Crisis Teams how to input their data. DMH also distributed a "Frequently Asked Questions" document and a corresponding reference manual to each of the CMHC Mobile Crisis Response Teams. CMHCs were asked to test the WITS Mobile Crisis Module during the fourth quarter of Fiscal Year 2022 (April – June 2022). Additionally, inclusion of the WITS Mobile Crisis Module data in the above-described Data Validation and Reconciliation reviews began in April 2022.

On July 1, 2022, the Mobile Crisis Module in WITS went "live" and became the official platform for the CMHCs to submit their Mobile Crisis Response data to the Mississippi Department of Mental Health. At the beginning of Fiscal Year 2023, early Mobile Crisis Response WITS data review activities were focused on partnering with the CMHCs to define mobile crisis and the parameters for capturing and reporting data correctly as well as on identifying and correcting any origination issues, such as the user's ability to bypass the mobile call disposition screen. In October 2022, DMH staff began monthly calls with the CMHCs to review their monthly Mobile Crisis Response data submissions through the WITS system. Data reconciliation efforts continue to be made with Mobile Crisis-related data across the state, specifically pertaining to differentiating between Mobile Crisis Services and Crisis Response Services.


Towards the end of Fiscal Year 2023, training sessions were held between CMHCs and Mobile Crisis and Information Systems representatives at the Mississippi Department of Mental Health. WITS Crisis Module training sessions continued in Fiscal Year 2024. Organizational processes in which Mobile Crisis data is entered at the regional level will continue to be an area of focus for Fiscal Year 2025.

The DMH Office of Utilization Review was begun in April 2022. This office is responsible for reviewing the utilization of behavioral health services for state-operated programs and key community-based services with a focus on preventing unnecessary hospitalizations. The collection of key data indicators from the four (4) State Hospitals (SHs), was begun in Fiscal Year 2022 through the DMH Office of Utilization Review; these efforts continued and were enhanced in Fiscal Year 2023 and Fiscal Year 2024.

In Fiscal Year 2023, Data Validation Calls relating to State Hospital-specific data indicators were initiated through the DMH Office of Utilization Review and continued in FY 2024. State Hospital Directors and/or their hospital representatives participated in quarterly data validation calls with the Division of Utilization Review for the purpose of validating monthly data submissions and correcting any noted data discrepancies. In Fiscal Year 2024, the Division of Utilization Review's data review and monitoring efforts focus on a collaborative emphasis in coalescing data review activities among Mobile Crisis Services, other Adult Community Mental Health Core Services, and State-Operated Behavioral Health programs for the purpose of engaging in multi-level macro analyses, trending and forecasting of service allocation, provision and utilization across the public adult mental health service delivery system.



2024.





• Illustrated in the chart below, the average number of days individuals spent waiting in jail prior to a State Hospital admission (among all four (4) State Hospitals) decreased from an average of 8.46 days in Fiscal Year 2022 to an average of 4.77 days in Fiscal Year 2023, and for Fiscal Year 2024 averages of: 2.69 for the 1st Half, and 1.86 for the 2nd Half. The table on page 16 provides more specific information.




A total of <u>1,882</u> State Hospital admissions (among all four (4) State Hospitals) were reported for Fiscal Year 2024.
 Of this total number of admissions, <u>624</u> (approximately 33.2%) were admissions from Same Level of Care (SLOC) programs.





Admissions to Residential Crisis Services by Region and Entity - Report Narrative

During Fiscal Year 2024, Crisis Stabilization Unit admissions were captured through two (2) different data reporting mechanisms. The first data reporting mechanism involved each Crisis Stabilization Unit, run by the respective Regional Community Mental Health Center (CMHC), submitting a monthly grant outcome report to the DMH Division of Adult Services. This monthly grant outcome form included, but was not limited to, the following data fields: "Total Number of Admissions," "Male and Female Admissions," and "Referral Source of Admitted Individuals." This information was entered into the Qualtrics database for tracking and monitoring. It should be noted that the "Total Number of Admissions" on the monthly grant outcome form was not unduplicated. Therefore, this number captures total admissions, including an individual who may have been served multiple times, at multiples CSUs, throughout the state during the designated reporting period.

Admissions to Residential Crisis Services by Region

The second data reporting mechanism includes data transfers (Crisis Stabilization Unit admissions, differentiated by Regional Community Mental Health Centers) from each respective CMHC's Electronic Health Record (EHR) to the DMH Data Repository, the Data Warehouse. For this report, 3,873 admissions were reported by the CMHCs for July 1, 2023–June 30, 2024.

At the end of Fiscal Year 2024, there were a total of 196 active CSU beds across the regions; however, Region 8 added a 16-bed facility in February of 2024, which was not processed in CSU admissions report within the Data Warehouse in FY24. Region 3 also certified 8 additional beds in June of 2024, giving the state a total of 204 certified beds across the state of Mississippi.

For Fiscal Year 2024, monthly self-reports were submitted from the four (4) State Hospitals to DMH via partial data extraction from hospital Electronic Health Records systems, supplemented with electronic and manual collection, review and reporting methods. Two (2) data items were submitted from each hospital: 1) the number of individuals admitted to state hospitals from Crisis Residential Services and 2) the number of individuals admitted to state hospitals without having first been served in Crisis Residential Services.



Mobile Crisis Response Team Narrative:

As previously indicated, the WITS Crisis Module went "live" on July 1, 2022. CMHCs were asked to test the system during the fourth quarter of Fiscal Year 2022 (April – June 2022). Training sessions were held to teach Mobile Crisis Teams how to input data into the WITS Crisis Module system. A "Frequently Asked Questions" document and a reference manual were distributed to all Mobile Crisis Response Teams.

Each month, Mobile Crisis Response data is examined by DMH leadership staff; this data is also reviewed by fidelity reviewers throughout the year as well as prior to each mobile crisis fidelity site visit. Throughout this review process, data fields are continually refined to meet the needs of DMH staff and Mobile Crisis Teams, and identified errors are corrected in the system. WITS data review meetings are held monthly with the CMHCs; these meetings include an Information Systems representative from DMH, a Crisis System Coordinator at DMH, and the CMHC Mobile Crisis Response Teams. During these meetings, data issues and/or data discrepancies are identified and reviewed. The Crisis System Coordinator then meets with Mobile Crisis Team Coordinators and/or representative(s) working on data entry at the CMHCs to review any noted issues and to make corresponding corrections.

Civil Commitments to State Hospitals by CMHC by Region and County - Report Narrative

For Fiscal Year 2024, monthly self-reports were submitted from the four (4) State Hospitals to DMH via partial data extraction from hospital Electronic Health Records (EHR) systems, supplemented with electronic and manual collection, review and reporting methods. This report is organized by CMHC region and by county. The county-level aspect of this report is based on the counties in which the corresponding commitment orders to the respective state hospitals were issued.

For Fiscal Year 2024, a total of <u>2,772</u> commitments to State Hospitals were reported. A total of <u>1,882</u> acute adult psychiatric admissions to state hospitals were reported for this same time frame. As these numbers indicate, not all commitments resulted in corresponding state hospital admissions (due to such factors as successful diversions from a state hospital level of care and persons being served by private, same level of care providers). Data validation and reconciliation efforts comparing the number of state hospital admissions to the number of commitments and the number of admissions first served by Crisis Residential Services was begun in Fiscal Year 2022 and has continued in Fiscal Year 2024.

Individuals who remain hospitalized in State Hospitals for over 180 days - Report Narrative

This report is comprised of monthly self-reports submitted from the four (4) State Hospitals to DMH via partial data extraction from hospital Electronic Health Records (EHR) systems, supplemented with electronic and manual collection, review and reporting methods. It includes an unduplicated count of the number of individuals at each state hospital with a hospital length of stay which exceeded 180 days during the covered time frame (Fiscal Year 2024). This report excludes the following patient populations: forensic, nursing home, substance use primary/Chemical Dependency Unit, and children/adolescents.

Services to Prevent Higher Level of Care

- Reported data points were extracted from the Data Warehouse, the Department of Mental Health's data repository. The Data Warehouse system only accepts established "patients"/individuals with each respective CMHC and is based on accurate and reliable data transfer from each CMHC's respective EHR to the Data Warehouse. This method includes having the noted data fields correctly mapped to the correct service codes in the Data Warehouse and requires that the data submissions be entered correctly into the respective EHRs in a timely manner. Reports for the July 1, 2023 June 30, 2024, service period were generated for this report on September 25, 2024. These reports may differ from other reports given that they were run two months after the end of Fiscal Year 2024 and that data is constantly being reconciled for accuracy. These reports are an accurate representation of the data available to review in the Data Warehouse as of this date.
- As stated previously, there were mapping issues following the opening of the new Crisis Stabilization Unit in Region 8. The Region 8 Brandon CSU has minimal data available for review in the Data Warehouse due to the transition of establishing another location code that corresponds between the EHR and in the Data Warehouse. It is important to note that the limited Region 8 CSU data in the Data Warehouse affects Crisis Residential service provision data and Crisis Stabilization Admission data and should be interpreted as an overall underestimation of service provision.
- It should be further noted that differences may occur in the total number of individuals served between the Data Warehouse and the graph depictions, as Data Warehouse filters out duplicated individuals for its total, and the graphics displayed cannot examine the Unique Client Identifier behind each number presented. The Data Warehouse reporting mechanism is attached to each unduplicated individual regardless of where the individual received services. The Data Warehouse analytics defined an "unduplicated individual" in such a manner that a single individual within a respective CMHC may be counted more than once, if the individual was served at multiple designated facilities within the respective agency (e.g., Region X main office, Region X satellite office). Additionally, individuals served by more than one CMHC, in a given service, may be represented multiple times in the displayed graphic breakdown for all impacted agencies, but are counted only once in the confirmed total as reported by the Data Warehouse.
- "Unduplicated Individuals Served" signifies that an individual received a given service (e.g., PACT, ICORT, etc.). "Unduplicated" means that the individual is not counted more than once and is recognized as a distinct data point. An individual may be on an intensive service caseload. However, if the individual did not receive a service while on that caseload, then the person's service data would not be included in the Data Warehouse metrics. Data Warehouse metrics represent only individuals who have received a service.
- The "Regional CMHC(s) who provided service" column discriminates which CMHCs provided a given service for individuals who reside in each respective county. For instance, in the Crisis Residential Services table below, 62 unduplicated individuals who resided in Coahoma County received Crisis Residential Services (i.e., services at a CSU) from Regions 2, 6, and 9. Although Coahoma County is in the Region 6's catchment area, individuals received care at CSUs outside of Region 6.




Crisis Stabilization Unit (CSU) Admissions and Crisis Residential Services – Report Narrative

Twenty-four (24) individuals received care at a CSU operated by Regions 2, 4, 6, 8, 9, 10, 12, and 14 whose records indicated that they resided outside the state of Mississippi. Eighty (80) individuals received care at a CSU operated by Regions 3, 10, and 12; however, their county of residence information was "missing" from their service enrollments; these individuals were therefore listed as having "Missing Data." It should be noted that the Services by Residence County report differs from the All Services and Crisis Residential report in the Data Warehouse. The totals from the Services by Residence County report will not match the unduplicated total in the other reports due to additional data from the Children and Youth Crisis Stabilization Unit, Ruth Wilson, and due to mapping errors that can occur when Crisis Residential Service Codes are not correctly mapped to the location codes of respective CSU locations.









Peer Support - Report Narrative

The Peer Support referenced in this report and related data metrics, is specific to Peer Support services provided outside of bundled services such as PACT, ICORT, CSU, and Mobile Crisis. The Peer Support referenced above also does not include Peer Support or Peer Bridger services provided at the state psychiatric hospitals. The charts above and below depict the counties from which the highest number of Peer Support Services were provided, and the regional breakdown by whom individuals were served, respectively.



Key Terms & Definitions

- Services to Prevent Higher Leel of Care: The set of services for adults with serious mental illness identified
 as being key to the prevention of unnecessary hospitalization in state psychiatric hospitals. These services
 are: Mobile Crisis Teams, Crisis Stabilization Units, Programs of Assertive Community Treatment, Intensive
 Community Outreach and Recovery Teams, Intensive Community Support Services, Permanent Supported
 Housing, Supported Employment, Peer Support, and Community Support Services.
- County of Referral: County of Referral means the county in which a referral was initiated for a given service.
- County of Residence: County of Residence refers to each person's county of residence based on the person's reported address in the respective CMHC's Electronic Health Record.
- Data Warehouse: System utilized by the Mississippi Department of Mental Health for capturing data from certified providers for federal and state reporting.
- DMH Operational Standards: The Mississippi Department of Mental Health Operational Standards for Mental Health, Intellectual/Developmental Disabilities, and Substance Use Community Service Providers, commonly referred to as the DMH Operational Standards, is DMH's published set of promulgated rules for agencies which are certified or are seeking certification by the Mississippi Department of Mental Health. This document is part of Administrative Code through the Mississippi Secretary of State's Office.
- Missing Data: Missing Data does not refer to the absence of data, but rather an element of data entered (e.g., individual served was reported but County of Residence was missing).
- **Mississippi Home Corporation:** Mississippi Home Corporation administers the legislative funding for CHOICE vouchers to the four Housing Resource Providers.
- Out of State: Out of State refers to a person being served in Mississippi with a reported residence outside
 of Mississippi.
- Same Level of Care (SLOC): Term which generally refers to an equal or comparable standard of medical treatment or service.
- Statewide Capacity to Serve: The capacity of a fully staffed service team at any single point in time.
- Web Infrastructure for Treatment Services (WITS): System utilized by the Mississippi Department of Mental Health for capturing data from certified providers for federal and state reporting.




